Remote Proceedings

In addition to in person proceedings using appropriate safety precautions, Ms. Davis is available for mediations and arbitration hearings via videoconference and teleconference.

Terms of Engagement

Daily Mediation/Arbitration Rate (7 hours) \$3,200 day, plus reasonable expenses (if any)

Cancellation Fees

Cancellations made more than one week in advance of a scheduled mediation/hearing will be subject to a \$750 charge. Cancellations made less than one week in advance of a scheduled mediation/hearing will be subject to a charge of 75% of the full cost, plus an hourly charge for any study time already completed.
